

PERSONAL DATA PROTECTION POLICY

PRESTASHOP ADDONS

Including the Cookies Policy

April 2024

Normally, you place particular importance on how your data is obtained, used, and shared.

This personal data protection policy (the "Policy") illustrates the commitment of PrestaShop S.A – Société Anonyme registered in the Paris Trade and Companies Register under number 497 916 635 and whose offices are located at 198 Avenue de France - 75013 PARIS ("**PrestaShop**") – as data controller concerning respect for the privacy and protection of the personal data of its users.

Also, this personal data protection policy (the "**Policy**") has been written to allow you to become aware of the practices and conditions under which PrestaShop collects, uses, and stores your personal data (the "**Data**").

There you will find the different Data that we may collect and process or that you may transmit to us when you access and/or use:

- the site <https://addons.prestashop.com> (the "**Site**") on which (a) modules and themes (the "**Addons**") developed by PrestaShop or third-party developers ("**Vendors**") as well as (b) proposed interfaces (the "**Connectors**") allowing you to use third-party services offered by official PrestaShop partners (the "**Official Partners**") identified as such on the Site;
- the site <https://validator.prestashop.com> allows Vendors to validate their Addons before their publication on the marketplace which requires the provision of their Site user identifiers;
- the sites <http://doc.prestashop.com> and <http://demo.prestashop.com> which respectively allow users to read the documentation relating to the development of Addons and the operation of the solution.

The term "**Site**" designates only the site <https://addons.prestashop.com> while the term "**Sites**" designates all of the aforementioned URLs.

Given the constant evolution of laws and regulations regarding technology and the protection of personal data, it is likely that this Policy will be updated.

If you are a user of the Site, you will be informed of any modifications by email.

If any of the clauses of this Policy were to be declared void or contrary to the regulations, it will be deemed unwritten but would not result in the nullity of the other clauses of this Policy.

This Policy applies to the Data collected:

- Via the Sites;
- Via emails exchanged between PrestaShop and you or any other electronic messaging tool;
- Via customer reviews collected directly or through a dedicated form;
- When you create a user account on the Site;
- When you subscribe to the Site Newsletter.

It does not apply to information collected by any third parties or through sites managed by them; including via applications or content (including advertisements) redirecting the user to the Sites.

We thank you for reading the Policy carefully to clearly understand our practices regarding the processing of your Data and inform you that consultation and/or use of our Sites necessarily entails acceptance of this Policy.

If the latter does not obtain your membership, we invite you not to use our Sites.

It is your responsibility to ensure that the Data communicated to PrestaShop is complete, accurate, and up to date.

1. WHAT DATA IS COLLECTED BY PRESTASHOP?

Depending on the nature and purpose of your interaction with PrestaShop (creation of a user account and/or exchanges via the chat tool, subscription to the Newsletter, completion of contact forms, as well as during possible telephone exchanges), we may collect the following Data:

- Data relating to your identity such as your last name, first name, user category, and email address, may be requested from you;
- Browsing Data: information related to internet behavior (traffic data, log files, and other communication data or resources that you use when accessing our Sites).
- Connection Data: information linked to the technical identification of a natural person
- Professional activity data such as turnover;
- Telephone conversations;

- Data relating to transactions: your postal address is necessary for issuing invoices. Likewise, your bank or PayPal details must be provided to pay for your order;
- Data relating to the use of social networks when you use their functionalities.

In addition, if you are a Vendor, we may collect the following Data:

- Your postal address;
- Data relating to your country but also your language;
- Your bank or PayPal details;
- Data relating to your customer reviews that you leave via the customer review form sent following your subscription to one of our services or the purchase of an Addon on our marketplace.

2. HOW IS YOUR DATA COLLECTED?

Data may be collected in different ways on the Sites.

The Data may be collected directly when you transfer it to us using the contact and user account creation forms, Newsletter subscription, or forms relating to customer reviews available on the Site and/or communicated when you contact us by telephone.

When you contact us using these different means, a copy of your exchanges with PrestaShop, including email addresses, is made and archived.

PrestaShop also indirectly collects your Data using cookies/trackers. We invite you to read our Cookies Policy below, intended to help you better understand these technologies and the use we make of them on our Sites and as part of our services, applications, and tools.

3. FOR WHAT PURPOSES DO WE COLLECT THIS PERSONAL DATA?

- Manage assistance/support services;
- Notify you of changes to our Sites or our offering of products and services;
- Manage possible disputes;
- Comply with our rights and obligations stipulated in contracts concluded with users as well as for any other legal purpose.
- In particular, if you are a Customer:
 - Allow you to create a Customer account;
 - Allow you to use the interactive features of the Sites and make purchases of Addons and/or download Connectors on the Site;
 - Send you information regarding your account (including purchase invoices, and order history);
 - Allow you to leave a review on Addons and Connectors. Please note that customer reviews are processed for referencing, management, and improvement purposes of the marketplace and can be used for marketing purposes.
- In particular, if you are a Vendor:
 - Allow you to create a Vendor account;
 - Validate your Addons on the site <https://validator.prestashop.com>;
 - Offer your Addons on the Site;
 - Make purchases of Addons following our contractual obligations;
 - Furthermore, your bank or PayPal details must be provided so that PrestaShop can proceed with the payment of your commissions following our contractual obligations;
 - Send you information regarding your account and in particular monitor the sales of your Addons and repay the commissions due to you.

On the other hand and for certain specific purposes, we also consider that we have a **legitimate interest** has ensuring the continuity and improvement of our services.

Communicate with you, notably:

- Handling requests for information and comments,
- Respond to your contact requests,
- To advise you,
- Communicate changes and updates,
- You alert in the event of security incidents.

We consider that we have a **legitimate interest** in ensuring the continuity of our services.

Carry out commercial prospecting actions, involving, in particular, sending you:

- Newsletters,
- our personalized commercial offers as well
- our news.

We consider that we have a **legitimate interest** in carrying out commercial prospecting actions following the recommendations of the French supervisory authority regarding B2B commercial prospecting. You can object to this prospecting at any time via the unsubscribe links contained in the emails or by contacting the address privacy@prestashop.com.

Perform data analyzes

We consider that we have a **legitimate interest** in carrying out data analyzes to continually improve our services.

Meet our legal requirements

We are subject to legal **obligations** requiring in particular, to respond to requests from authorities, to respect laws and regulations, and to respond to requests to exercise rights mentioned in Article 8 of this Policy.

Ensuring the security of our services, notably:

- Fraud detection and prevention,
- Information system security.

We consider that we have a **legitimate interest** in ensuring the security of our services.

We also use cookies or trackers. To find out the purposes and retention periods of the data resulting from this use, we invite you to consult the Addons Cookies Policy below.

Refusal to provide certain data may result in the unavailability of certain services.

4. WHO PROCESS YOUR DATA?

Your Data may be processed by PrestaShop employees.

Your Data may be transmitted to any buyer or other successor in the event of a merger, assignment, restructuring, reorganization, dissolution, or other sale or transfer of part or all of the assets of PrestaShop due to uncertainties or bankruptcy, liquidation or other processes in which User Data from the various PrestaShop sites are among the assets transferred.

Furthermore, as part of our activity, and for external processing purposes, your Data may be communicated to subcontractors, service providers, or other third parties. The latter is obliged, by a Data subcontracting contract, to respect the confidentiality of the Data and to use it only for

the purposes for which we transmit it to them. In addition, transfers of Data outside the European Union are subject to the signing of standard contractual clauses with them.

The list of subcontractors is available in Appendix 2.

- **For the management of after-sales service for Addons**

If you are a Customer, your strictly necessary Data may be communicated to the Vendor whose Addon(s) you have downloaded so that they can provide after-sales service.

Under no circumstances can PrestaShop be held responsible for how your Data will be stored or used by the Vendor(s).

- **For payment management**

To facilitate the experience of its Customers, PrestaShop offers the following payment methods to make purchases on the Site:

- Online payment by Bank Card (Carte Bleue, Visa Card, Eurocard / Mastercard) in the 3 currencies available with Be2Bill;
- Payment by PayPal in the 3 currencies available on PrestaShop Addons;
- Payment by bank transfer in the 3 currencies available on PrestaShop Addons.

Payment processing is carried out by our partners Paypal and/or Stripe depending on the option selected.

PrestaShop has no access to your identifiers and bank card numbers.

All transactions are secured using SSL encryption, ensuring both the identity of the payment institution and data confidentiality.

- **For the management of the partnership with our Official Partners**

When you download the Connectors allowing you to use the third-party services of our Official Partners, your Data (date of download of the Connector, email address, URL of your website, first and last name) is communicated to the latter to

(i) to enable us to monitor the management of the partnership concluded with PrestaShop, and

(ii) to enable them to provide you with personalized commercial offers.

5. LEGAL DISCLOSURE

Finally, we may also disclose your Data:

- to comply with any legal mandate, law, or legal process, including governmental and regulatory requests;
- if we believe that disclosure is necessary or appropriate to protect the rights, property, or safety of PrestaShop, its customers, or other stakeholders.

Such disclosure includes exchanging information with other companies and organizations for protection against fraud and counterfeiting.

6. HOW LONG IS YOUR DATA KEPT?

PrestaShop only keeps your Data for the duration necessary for the purposes set out in Article 3.

This retention period is not the same depending on the Data in question, the nature and purpose of the collection is likely to cause this duration to vary. Likewise, certain legal obligations impose a specific retention period.

When you subscribe to the Newsletter, we keep your email address until you unsubscribe.

When you contact PrestaShop using the various contact forms in the Help Center or when you communicate with us by telephone or via the chat tool, your data will be kept for up to five (5) years from the last contact.

When you leave a comment or review on our modules, themes, or any other service offered on the Addons Marketplace, we keep them and can use the pseudonym you used to communicate the content until eighteen (18) months later. the issuance of the opinion.

Concerning your user account, your billing data is retained for ten (10) years from the date of purchase.

Finally, we keep some of your Data longer if necessary, for legitimate business purposes or if the law requires us to do so (whether for security purposes, financial data archiving, or fraud prevention and abuses).

When you delete or request the deletion of your Data, we ensure the effectiveness of this deletion or their conservation in anonymized form.

Data collected through cookies and other trackers is kept for thirteen (13) months from their collection.

Beyond the aforementioned retention periods, your Data will be anonymized to be kept for statistical purposes only.

7. HOW IS YOUR DATA PROTECTED?

Your Data is stored on secure servers and protected by firewalls and antiviruses.

We have implemented technical and organizational measures intended to guarantee the security and confidentiality of your Data against any accidental loss and any unauthorized access, use, modification, and disclosure.

Given the particularities inherent to the Internet, it is however impossible for us to guarantee optimal security of the exchange of information on this network.

We strive to protect your Data, but we cannot guarantee the absolute security of information transmitted to the Site. You agree that you transmit your Data at your own risk.

We cannot be held responsible for non-compliance with the privacy settings or security measures in place on our Sites.

As such, you agree that the security of your information is also your responsibility. For example, it is your responsibility to keep secret the password allowing you to access your user account.

Do not under any circumstances disclose it to third parties. Likewise, be careful when disclosing information in the public sections of the Site, which can be consulted by any user of the Site.

The Sites may contain links to various sites and social networking platforms managed on third-party servers, by people or organizations over which PrestaShop has no control.

Therefore, we cannot under any circumstances be held responsible for how your Data will be stored or used on the servers of these third parties.

We advise you to read the applicable personal data protection policy of each third-party website to which you access via our Sites to assess how your Data will be used.

8. WHAT ARE YOUR RIGHTS?

You can choose how the Data you transmit to us is used:

You can browse the Sites without providing any Data. If applicable, you will not be able to use certain features of the Sites and in particular, make purchases (if you are a simple user) or sales (if you are a Vendor) of Addons and/or downloads of Connectors. on the site.

Likewise, if you are a Vendor, you will not be able to validate your Addons on the site <https://validator.prestashop.com>,

- You can refuse to provide your bank or PayPal details and/or your postal address. In this case, you will not be able to make a purchase or receive your commissions if you are a Vendor,
- You can decide to no longer receive the Newsletter as well as our personalized offers: simply log in to your Site user account or click on the link in the email sent to you.
- You can decide to no longer receive personalized commercial offers sent to you by our Official Partners. You will then simply have to oppose this prospecting by all the means made available by them.
- When you leave a review on the page of the Addon you purchased, you have the option of using a pseudonym,
- You can choose not to provide your email address in the Help Center. Please note that you will not be able to obtain a response from PrestaShop.
- In any case, you have the possibility of accessing your user account at any time to consult or update your Data and unsubscribe from our Newsletter.

In accordance with the provisions of the regulations applicable to the protection of personal data, in particular European Regulation 2016/679 on data protection (the “GDPR”) as well as the law of January 6, 1978, n°78-17 known as “Informatique et Libertés” and its modifications, you have a right of access and a right of rectification over your Data.

You also have the right to define guidelines relating to the fate of your Data in the event of death.

In addition, subject to the conditions provided for by said regulations for the exercise of these rights, you benefit from:

- A right to the erasure of your Data;
- A right to limit the processing of your Data;
- A right to object to the processing of your Data for legitimate reasons, in accordance with Article [21 of the GDPR](#) ;

- A right to portability of the Data you have provided (for automated processing based on consent or the execution of a contract);
- The right to withdraw consent, when this has been requested. You acknowledge, however, that processing carried out before the revocation of your consent remains perfectly valid.

However, in accordance with article 12.6 of the GDPR, for the exercise of these rights, PrestaShop, as data controller, reserves the right to ask you to prove your identity. We inform you that the data used to prove your identity will be deleted once we have responded to your request.

We have one month to respond to any request relating to the exercise of your rights. This deadline may be extended by two months, due to complexity or too many requests.

Finally, you also have the right to complain to the CNIL (National Commission for Information Technology and Liberties), in particular via its website www.cnil.fr.

9. DOES PRESTASHOP TRANSFER MY DATA OUTSIDE THE EUROPEAN UNION?

In accordance with Article 4 above, Data may be transmitted to our Official Partners and/or Subcontractors located outside the European Union. In this case, PrestaShop makes every effort to ensure the security of Data passing outside the European Union.

ANNEXES

Appendix 1. COOKIE POLICY

When you visit or use the Sites, PrestaShop or its partner service providers may use cookies or any other tracking/tracking/automatic data collection technology to store information to provide you with an improved, faster, and faster experience. more secure.

This cookie policy aims to help you better understand these technologies and our use of them.

1. WHAT IS A COOKIE?

Cookies are small text files (most often consisting of letters and numbers), stored in the memory of your browser or device when you visit a website or view a message.

They allow a website to recognize the browser or device. Like most websites, PrestaShop uses technologies, mostly through small data files stored on your device that allow us to record certain information when you visit or use our Site.

There are several types of cookies:

4. Help us provide you with relevant and targeted advertising.

We use cookies or any other similar tracking technology (SDK, tags, etc.) that remain on your device only while your browser is open (session cookies), and cookies or any other similar technology which remains on your device for a longer period (persistent cookies).

- **Necessary cookies or trackers**

PrestaShop issues session cookies and other trackers, strictly necessary for the proper functioning of the Sites and your navigation on them.
