

RULES OF THE COMPETITION PRIZE DRAW

"1 voucher for €49.99 offered each day"

Article 1 - Competition definition

Organizing company

The company PRESTASHOP (hereinafter referred to as "PRESTASHOP"), a limited liability company with a capital of €339,227.10, registered in the Paris Trade and Companies Register under number B 497 916 63, whose head office is located at 12, rue d'Amsterdam - 75009 PARIS France.

2. Game competition

This game is entitled "1 voucher for €49.99 offered each day" (the "Game") and will take place on the website <https://addons.prestashop.com>, owned by PRESTASHOP. This game is designed to promote the modules sold by PRESTASHOP to customers of the online retail solution published by PRESTASHOP, by giving them the opportunity to win money off a module developed by PRESTASHOP ("PRESTASHOP module") as part of a prize draw.

3. Competition dates

The Game will begin on the 8th December 2019 at midnight, and will be open until the 22nd December 2019 at midnight.

All times are in French time.

Article 2 - Participation conditions and validity

Conditions of participation

Any private individual who is of legal age or a corporate entity acting in the course of their professional activity and who holds a free Addons account (hereinafter referred to as "the Participants") may participate in the Game.

Participants must have unconditionally accepted these rules in full to be able to participate. Failure to comply with these terms and conditions or any fraudulent behaviour will automatically result in the participants' immediate withdrawal from the Game.

Valid participation

In order for participation in the Game to be taken into account by PRESTASHOP, the Participant must:

- Be in possession of an Addons account;
- Read and accept the rules;
- Place an order containing at least two modules developed by PrestaShop, with no minimum purchase;
- Have paid for the order using one of the payment methods offered by PrestaShop Addons.

There is no limit to the number of participants in the Game, each order from Participants who meet the stated participation conditions will be taken into account for that day's prize draw.

However, each Participant may win a maximum of two vouchers throughout the entire duration of the Game. They cannot be accumulated on a future order.

Article 3 - Details of the prize draw

A prize draw will be conducted by a script on a daily basis throughout the duration of the Game, for a total of 15 (fifteen) prize draws.

- The winner of each draw will be announced at 10:00 a.m. the day after they entered the draw.
- The winner will be announced once their eligibility has been verified.
- The winner will be informed by an email sent to the address provided when creating their Addons account.

Article 4 - Allocations

Each of the winners will be offered a €49.99 voucher to be used on all modules developed by PrestaShop. It will be valid until 31.01.2020. It will not be cumulative, redeemable for cash, or divisible.

The voucher will be sent by email to the address provided when creating your Addons account.

Article 5 - Personal data

It should be remembered that, in order to participate in the Game, Participants have to provide certain personal information concerning themselves: the information required to create an Addons account (e-mail address, surname, first name, navigation data, data relating to visits to the PRESTASHOP Addons website, data relating to purchases made, social network data, postal address, location data (country), language, bank details and PayPal). This information is recorded and saved in a computer file. This data is required for a valid participation, to determine the winners and to allocate prizes. This information is intended for PRESTASHOP as part of the Game, and may be transmitted to its technical service providers in order to distribute the prizes.

The Participants agree that the data collected may be processed by PRESTASHOP and may be used for commercial purposes.

In accordance with applicable legislation on the protection of personal data, Participants have a right of access, a right of information and a right to delete data concerning them. Participants may exercise their rights at any time by writing to: privacy@prestashop.com.

Participants exercising their right to delete their data before the end of the competition will be considered as waiving their participation.

Article 6 - Filing of the regulations and communication

- a banner displayed in the back-office and user front-office;
- a banner displayed on the website <https://addons.prestashop.com>;
- a sponsored ad on Facebook.

Article 7 - Applicable law and disputes

These regulations are subject to French law.

In the event of disputes or complaints concerning this Game, requests must be addressed to PRESTASHOP within fifteen (15) days after the end of the Game.

In the event of persistent disagreement on the application or interpretation of these regulations, and in the absence of an amicable agreement, any dispute shall be submitted to the Commercial Court of Paris (France), to which exclusive jurisdiction is attributed.

Article 8 - Limitation of liability

Participation in the Game constitutes understanding and acceptance of the features and limitations of the Internet, including technical performance, the time required to respond to a request for access to, the consultation of, or the transfer of information, the risks of interruption, and more generally, the risks associated with any internet connection and transmission, the failure to protect certain data against possible misuse and the potential contamination by viruses that circulate throughout the internet.

Consequently, PRESTASHOP cannot under any circumstances be held responsible for, including but not limited to, the following:

- the loss of any documents or electronic mail and, more generally, the loss of any data;
- routing problems;
- the operation of any software;
- the consequences of any virus, computer bug, anomaly or technical failure;

- any damage caused to a Participant's computer;
- any technical, hardware and software failure of any kind that prevented or limited the possibility of participating in the Game or which causes damage to a Participant's system;
- the malfunctioning of the prizes distributed as part of the Game, and any direct and/or indirect damage they may cause.

It is specified that PRESTASHOP cannot be held responsible for any direct or indirect damage resulting from an interruption or malfunction of any kind, for any reason whatsoever, or for any direct damage resulting, in any way, from a connection to the <https://addons.prestashop.com> site.

It is the responsibility of each Participant to take all appropriate measures to protect their own data and/or computer software and equipment against any type of unauthorised access. All persons connecting to the <https://addons.prestashop.com> website and all Participants taking part in the Game do so at their own risk.

PRESTASHOP has the right to cancel the Game, in whole or in part, if it is found that fraud has been committed by any means whatsoever, including computer fraud or the fraudulent identification of the winners. In this case, it reserves the right not to award allocations to perpetrators of fraud and/or the right to prosecute the perpetrators of such fraud before the competent courts. The Game is not managed or sponsored by Facebook. Facebook can therefore, under no circumstances, be held responsible for any dispute related to the Game. Any questions, comments or complaints concerning the Game should be addressed directly to PRESTASHOP.

PRESTASHOP reserves the right, for any reason whatsoever, to cancel, postpone, interrupt or extend the Game, or to modify the terms and conditions of these rules, in whole or in part, in full compliance with the latter.

If, as a result of an event beyond its control, it is forced to apply this right, it cannot be held liable.

PRESTASHOP reserves the right to permanently exclude any person from the various games who, by their fraudulent behaviour, could jeopardize the proper conduct of the games. In addition, the sponsorship of fictitious persons will result in the immediate elimination of the player. Similarly, any attempt to use the game outside the unmodified interface set up on the site will be considered an attempt at fraud. In addition, the decomposition of the game, the use of personal scripts or any other attempt to circumvent the intended use of the game as set out in these rules will also be considered an attempt at fraud and will result in the immediate and non-reciprocal elimination of the player.
